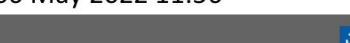

2. The ethical guideline for acceptance of donations as described in the Leiden University Guidelines on the Acceptance of Gifts (www.luf.nl/guidelines) applies in addition to this Agreement. By signing this Agreement, the Donor declares that the donation conforms to the University's Donation Acceptance Directive in both content and origin, and the Donor agrees to the provisions of the Directive.
